Dr Simon Draycott has worked for the past fourteen years at Broadmoor Hospital, initially in the Dangerous Severe Personality Disorder service and more recently in the Mental Illness Directorate. He has carried out upwards of 100 assessments of mentally disordered offenders as part of this work, including assessment of risk to others (both violent and sexual), personality disorder, symptoms of mental illness and readiness for treatment. He regularly presents evidence to the criminal courts, parole boards and civil courts.

Since May 2013 He has also worked as a senior teaching fellow in clinical psychology at the University of Surrey, where he is responsible for the teaching of psychometric assessment, neuropsychology, adult mental health and research methods.

CRIMINAL AND PRISON LAW EXPERTISE

- Dr Draycott has specialist training and expertise in presenting evidence within the criminal courts, prison parole board hearings and mental health review tribunals.
- He has specialist training and expertise in the prediction of risk of offending in mentally disordered and personality disordered offenders.
- He has undergone training in models of forensic risk assessment for violence and sexual violence.
- He works with individuals with cognitive impairment and learning disabilities in mentally disordered offenders
- He works with self-harm or suicidal behaviour and is able to assess the risk individuals pose to themselves
- He has published in the area of motivation to change and is skilled in the assessment of an individual's ability to benefit from psychological therapy
- He has experience of assessment and treatment of with factitious illness (FIS)
