Dr McCormack is a Chartered Clinical Psychologist accredited by the British Psychological Society (BPS) and a Practitioner Psychologist registered with the Health and Care Professions Council, UK. Dr McCormack is a Bond Solon trained expert witness and has experience of given written and oral evidence in court proceedings. She completed clinical training at the University of Exeter, before pursuing a Clinical and Senior Leadership role with one of the largest IAPT (Improving Access to Psychological Therapies) service in the UK. She led this service for four years and moved on to a senior lecturer role on the clinical psychology training program at Exeter University and a further senior leadership role for a private psychology provision where she worked as Clinical Director. She specializes in family court assessments and has continued her practice within family court psychological assessment across these roles and has been drawn back to work within this area full time.

Dr McCormack has a high level of training and expertise in identifying and treating mental health difficulties including personality disorder, complex trauma and mood disorder. She has extensive experience of assessing individual adults and parents within family court proceedings and is trained in assessing safe parenting from a psychological perspective. She has also completed assessments for children and entire families within care proceedings and has lots of experience of assessing large families with complex dynamics. As such she is highly experienced at assessing across the lifespan and the diagnostic range. She has also completed multiple cognitive and capacity assessments within care proceedings.

Dr McCormack has experience of working with, assessing for and responding appropriately to complex mental health difficulties, attachment trauma, developmental trauma, risk and safeguarding issues. She is able to identify primary difficulties in order to direct evidence-based treatment and provide a stepwise programme of intervention along with timescales. As such she has an excellent understanding of realistic timeframes for treatment and the types of barriers that may impact the effectiveness of psychological treatment. She has experience of working with clients experiencing a range of physical and mental health difficulties, within both inpatient and out-patient settings, in a variety of different modalities, including individual, group, and couples therapy and have a particular specialism and passion for improving Adult Mental Health, in order to improve safe parenting.

Dr McCormack is an expert Assessor and has significant experience in carrying out complex assessments, utilising self-report measures, client interview, family interview, risk assessment and neuropsychological testing. She is experienced at writing detailed psychological reports and has significant experience of giving evidence in court.
