Current Position

Consultant in Child & Adolescent Psychiatry, Royal Free Hospital, and Clinical Service Lead.
In my current NHS post, which I have held since May 1993, I have four particular areas of responsibility: a. General outpatient and emergency service – We provide a comprehensive general service to the local population, for the whole range of general child psychiatric problems, including depression, anxiety, and developmental disorders. b. ADHD – We have a well established and busy ADHD service, closely linked with paediatrics, which treats local patients and also provides second opinions. c. Eating disorders - We run the NHS child and adolescent eating disorders service for several North London boroughs, seeing approximately 150 new patients a year. I set up this service and led it until mid 2018. d. Paediatric liaison – helping children and families cope with the psychiatric and psychological consequences of illness, physical or psychological, in a family member.

Medico-legal Work

For the past 25 years I have been providing expert opinions in a number of areas. Indeed I have prepared several hundred reports in child care cases and in personal injury claims. Areas of expertise include:

- Complex child care cases (public and private law), including assessment of parenting, child abuse (physical, emotional, sexual), consequences of parental mental health difficulties, induced illness, parental discord, residence disputes, assisted fertility, leave to remove, and attachment problems. I have particular experience with intractable contact disputes.
- Personal injury and medical negligence: accidents and other causes of trauma to children; consequences of alleged medical negligence; cases involving alleged failure by Local Authorities to protect children
- Cases where a current or former patient has committed suicide or suffered a serious injury.
- Advisor to the GMC on fitness to practice issues.
- Reports for Coroner's inquests.

Family Therapy

I give advice, outside of the Court setting, to parents who are separating or who are divorced, about ways in which they might reduce the impact of divorce on the children. with particular regard to the psychological wellbeing of the children.
