PROFILE

I am a super specialist in child and adolescent psychiatry with extensive knowledge of autism spectrum disorder, ADHD and other neurodevelopmental and childhood psychiatric disorders. I am a fellow of the Royal College of Psychiatrists and have done extensive research and work to advance the knowledge of psychiatry in children and adults. I understand the Neuroanatomy and the working of the brain of children. I have extensive knowledge of the effect of trauma, substances, environment, psychology, and deprivation on the brain of young people as well as how these factors could affect the transition to adulthood. I have worked competently as a clinician in the area of Clinical Neuropsychiatry. I am one of the very few psychiatrists in the United Kingdom who has a Royal College of Psychiatrists special dispensation in both General Adult Psychiatry and Psychiatry of substance misuse/forensic, and who is working at the highest level as a child and adolescent psychiatrist. This puts me in a unique position to see every child or adult irrespective of premorbid condition and have a good understanding of their developmental disorders as a child as well as an adult. I have super specialisation in the neuropsychiatric assessment and treatment of patients with acquired brain injury as well as children and adults with neurodevelopmental disorders. I have worked extensively in neurorehabilitation psychiatry as a consultant. My clinical interests include neurocognitive and neuro-behavioural disorders due to a Traumatic Brain Injury (TBI), Trauma and Stressor-related Disorders, Sleep-wake disorders, Non-Epileptic Attack Disorders (NEAD), Somatic Symptom and related Disorders (somatoform disorders), chronic fatigue syndrome (CFS), autism spectrum disorders (ASD) and attention deficit hyperactivity disorder (ADHD).

MEDICO-LEGAL SKILLS

I have extensive experience in medico-legal reporting across various jurisdictions including England and Wales, Scotland, Northern Ireland, and the Republic of Ireland. I have provided opinions to a variety of bodies and organizations including the Criminal Injuries Compensation Authority (CICA), the Court of Protection, the First tier Tribunal (Mental Health) and several Law Organizations, solicitors, and the insurance industry in civil cases. I have worked in forensic psychiatry in a medium and high secure unit, and I have provided more than a hundred medico-legal reports to the criminal justice system in criminal cases involving the crown.

I produce over 37 reports per year on complex Personal Injury and Clinical Negligence cases in both adults and children. I have been providing opinions on complex Personal Injury cases and Clinical Negligence cases since 2010. Currently, my annual workload is fairly evenly split between Personal Injury and Clinical Negligence cases. My percentage of work is approximately 65% (Claimant), 33% (Defendant), and 2% (Single Joint Expert). I attend court hearings and give evidence regularly. I regularly attend medico-legal courses/training annually as part of my Continuous Professional Development (CPD).

CLINICAL SKILLS

I have a postgraduate degree in mental health law, and I am highly competent in the assessment of Mental Capacity in patients presenting with neuropsychiatric disorders. I am also competent in the assessment and management of complex neuropsychiatric conditions including traumatic brain injury, chronic fatigue syndrome,



sleep disorders, epilepsy, non-epileptic attack disorders, somatoform disorders, and general neuropsychiatric disorders. I also have expertise in the assessment and management of general psychiatric disorders arising from trauma e.g. Post Traumatic Stress Disorder (PTSD). I am competent in the assessment and management of children and adults with neurodevelopmental disorders including ADHD and ASD. I am competent in the use of relevant psychopharmacological treatments and other physical treatments in the management of patients with neuropsychiatric conditions. I am able to diagnose and treat patients with medically unexplained symptoms. I am able to interpret neuropsychological test results sufficiently to produce a neuropsychiatric formulation in both adults and children. I am able to undertake the clinical assessment of patients presenting with neuropsychiatric disorders and request relevant investigations. I have excellent interpersonal and consulting skills as well as strong problem-solving abilities and clinical expertise. I am a team player with a strong record of patient engagement and advocacy. My clinical practice is characterized by innovative and evidence-based interventions with a strong patient-centred therapeutic approach, which aims to empower patients and promote independence, recovery, and well-being.

I have worked as a consultant psychiatrist at the highest level of the National Health Service (NHS) for the past 14 years.
